Please review and complete the attached NYSAA Collegial Review registration form. In response to last year’s feedback, the format of the **“typical” collegial review** has changed and will now be scheduled as individual half-hour appointments. These individualized appointments will provide an opportunity for special education teachers, administrators and NYSAA lead teachers to share their datafolios with an Alternate Assessment Training Network Specialist (AATN) in order to obtain professional feedback on their datafolios. Participants are expected to come to the collegial review with student datafolios that are in-progress or completed.

Please choose your preference of morning or afternoon and we will schedule your teachers for an appointment within that time frame. A maximum of 5 datafolios per half-hour session will be reviewed. It will need to be indicated on the registration form how many each teacher will be bringing so that we can schedule each appointment accordingly. You will receive the registration form back via fax with the scheduled date and time for each teacher registered.

Collegial Reviews are mandated by the NYSED. You may attend one of the collegial reviews scheduled at BOCES or you can conduct the collegial reviews in your own district/building.

We will also provide **turnkey collegial review training** for large districts (20 or more datafolios) or small districts who do not want to send their teachers to individualized half-hour appointments. In this full morning or afternoon session, we will train you so that you can return to your district and conduct collegial reviews with your teachers.
